**THE ASSESSMENT CENTER, A MULTI-AGENCY EVALUATION OF FAMILIES LED BY PENDLETON PLACE TO IDENTIFY ROOT CAUSES OF NEGLECT OR ABUSE AND ESTABLISH RECOMMENDATIONS FOR A PLAN TO IMPROVE THE WELL-BEING OF CHILDREN, ASSESSED 104 FAMILIES AND SUPPORTED 154 FOSTER FAMILIES. 177 CHILDREN WERE SEEN AT THE CENTER, LEADING TO 128 MEDICAL EXAMS, 75 MENTAL HEALTH DIAGNOSTICS, AND 62 DEVELOPMENTAL SCREENINGS. **THE CONNECTIONS COUNT AFTERCARE PROGRAM WAS GREATLY EXPANDED AND TRANSFORMED INTO THE YOUTH RESOURCE CENTER, WHICH OFFERS A COMPREHENSIVE ARRAY OF SERVICES TO RUNAWAY AND HOMELESS YOUTH. YOUTH WHO EXIT FOSTER CARE ARE A PRIORITY POPULATION. THE YRC SERVED 56 YOUTH WITH DROP-IN SERVICES, HOUSING SERVICES, CASE MANAGEMENT, AND OUTREACH. 76% OF CLIENTS EXITED THE STREETS AND/OR IMPROVED THEIR HOUSING STABILITY. 92% MAINTAINED PERMANENT HOUSING AFTER BEING STABILIZED. 38% IMPROVED THEIR EMPLOYMENT STATUS. THERE WERE 371 TOTAL VISITS DURING DROP-IN HOURS FOR SHOWERS, FOOD, LAUNDRY, AND BASIC NEEDS. WE PROVIDED \$38,286 IN DIRECT FINANCIAL ASSISTANCE TO ELIGIBLE YOUTH (RENTAL ASSISTANCE, DEPOSITS, MOVING COSTS, ETC.). 425 HOURS OF CASE MANAGEMENT WERE DELIVERED AND 31 MAJOR GOALS WERE ACHIEVED BY CLIENTS.**
